Competition Terms and Conditions

Terms and Conditions

- 1. The competition is open from Monday, 15th March until 5pm, Sunday, 30 May.
- 2. The activity is open to people of all ages, excluding employees of WWF-UK, and entries are permitted from Scotland only.
- 3. Only one entry per individual. Only entries that comply with all entry instructions will be accepted.
- 4. Paint or draw an original picture, write a poem or text, or make another form of creative contribution. Written contributions can be submitted in Gaelic, Scots or any language spoken in Scotland. Entrants must submit their entry digitally as a PDF or image file (JPEG or PNG). Submissions must be either:
 - a) Photography or scan of your contribution (e.g., scan of painting or drawing; photograph of sculpture, embroidery and other artworks)*, OR
 - b) Word or PDF file with written text contributions (e.g., poems and short stories)*
 - * For both a) and b) files should be at least 2 MB and no larger than 10MB. Ideally, the resolution of an image file should be minimum 300 dpi.
- 5. Entries must be the original work of the entrant's and not copied from any other source.
- 6. Entries must be submitted digitally to GreatScottishCanvas@wwf.org.uk and entrants must follow all directions to enter their name, post code, preferred contact details and a few words about their entry, including an attachment of the contribution itself. Contributors will be contacted after the closing date to confirm if their pieces will be used in marketing and exhibitions relating to this project.
- 7. The deadline for receiving entries is 5pm, Sunday 30 May. Any entries received after this deadline will not be considered. No entries will be returned.
- 8. WWF-UK accepts no responsibility for competition entries that are lost, mislaid, damaged or delayed in transit, regardless of cause including as a result of any postal failure, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind. Proof of sending is not proof of receipt of entry.
- 9. Any contact details supplied will be used solely for administering the competition and will not be published or provided to any third party without the entrant's explicit permission.
- 10. A number of entries will be selected to be displayed at a virtual exhibition and/or included in a published book. Entries will be selected based on the following criteria: it must closely follow the brief in all relevant areas, show evidence of creativity, and innovation, and be the contributor's original work not a copy of any kind. Entries must be received by the specified deadline. The decision of the panel is in their absolute discretion and their decision is final. No correspondence will be entered into.

- 11. A number of contributors will have their work showcased.
 - a) A number of contributors will have their work shown at a public exhibition in 2021.
 - b) A number of contributors will have their work printed in a book published in 2021.
- 12. Selected contributors will be contacted by email within 6 weeks of the closing date. List of selected contributors can be obtained 36 days after the closing date by sending a SAE to WWF Scotland, Jackson's Entry, The Tun, 4 Holyrood Rd, Edinburgh EH8 8PJ.
- 13. The contributors agree that WWF Scotland may use their name, image and town or country of residence to announce selected works and for any other reasonable and related promotional purposes. Selected contributors agree to participate in any reasonable publicity required by WWF Scotland which may include, but is not limited to, promotional photographs.
- 14. The contributors agree that WWF-Scotland may publish entries both in print and online, including on their websites, social media channels, and for PR purposes. WWF-Scotland reserves the right to amend/modify and or otherwise adapt the selected entry/entries as required.
- 15. WWF-UK reserves the right to cancel or amend the terms of this competition without notice at any stage if it is deemed necessary at the absolute discretion of WWF-UK.
- 16. In submitting an entry to this competition, you confirm that you are aged 18 or over and that you accept the terms and competition of the competition in full.
- 17. An adult aged 18 with parental responsibility may submit an entry on a child's behalf. The entry must include the child's name and age, but the contact details provided should be those of the adult with whom WWF-UK will liaise. By submitting the entry on the child's behalf, the adult accepts:
 - a) these terms and conditions in full and acknowledges that, in the event that the entry is selected, the named contributor will be the child/children;
 - b) that the selected child/children may be invited (with an accompanying responsible adult) to participate in publicity arising from this competition.
