

# GoFundMe WWF Richmond Kids Mile adoption prize draw

## Terms and Conditions

1. The prize drawer is open from 1<sup>st</sup> September to 6<sup>th</sup> November 2022
2. The prize draw is open to all WWF Richmond Kids Mile participants who set up a GoFundMe fundraising page, excluding employees of GoFundMe and WWF-UK.
3. Only one entry per individual.
4. Entrants must register for the WWF Richmond Kids Mile and have set up a GoFundMe fundraising page
5. The deadline to set up a page is **6th November 2022 at 23:59**. Any pages set up after this deadline will not be considered.
6. GoFundMe and WWF-UK accept no responsibility for competition entries that are lost, mislaid, damaged or delayed in transit, regardless of cause including as a result of any postal failure, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind. Proof of sending is not proof of receipt of entry.
7. Any contact details supplied will be used solely for administering the competition and will not be published or provided to any third party without the entrant's explicit permission.
8. All valid entries will be entered into a prize draw within 28 days of the closing date. Fifty entries will be drawn at random. The draw will determine the winner of the prize. No correspondence will be entered into.
9. The winners will receive a WWF animal adoption. The prize is non-transferable and cannot be exchanged for the cash equivalent. WWF-UK and GoFundMe reserves the right to substitute the prize for an alternative prize of equal or greater value. Prize winners are unable to select which animal adoption they will receive.
10. The winners will be contacted by email, within 4 weeks of the closing date, and will be asked to provide an address for their adoption kits to be sent to. If the winners cannot be contacted after reasonable attempts have been made, WWF-UK reserves the right to offer the prize to another competition entrant. Details of the winner can be obtained 28 days after the closing date by sending a SAE to WWF-UK, Living Planet Centre, Rufford House, Brewery Road, Woking, Surrey, GU24 4LL.

The winners agree that WWF-UK or GoFundMe may use its name, image and town or country of residence to announce the winner of the competition and for any other reasonable and related promotional purposes. The winner agrees to participate in any reasonable publicity required by WWF-UK which may include, but is not limited to, promotional photographs.

12. WWF-UK and GoFundMe reserves the right to cancel or amend the terms of this competition without notice at any stage if it is deemed necessary at the absolute discretion of WWF-UK and GoFundMe.

13. In submitting an entry to this competition, you confirm someone over the age of 18 has accepted the terms and conditions of the competition in full.

An adult aged 18 with parental responsibility may submit an entry on a child's behalf. The entry may include the child's name and age, but the contact details provided should be those of the adult with whom WWF-UK will liaise. By submitting the entry on the child's behalf, the adult accepts:

- a. these terms and conditions in full and acknowledges that, in the event that the entry is selected, the winner of the competition will be the child;
- b. that the winning child may be invited (with an accompanying responsible adult) to participate in publicity arising from this competition.
